## Meeting for Sufferings 1 April 2017

We were told by the Recording Clerk of the letter sent to the Parliamentary Under Secretary of State at the Department for Exiting the European Union. Our staff have compiled a schedule, to share with Friends, which gives details of the letters sent and communications entered into on behalf of Quakers in Britain. We, in our area meetings, can refer to these as seems appropriate. The list is included in the following papers.

## What will be different about the timing?

We don't expect any change to the meeting itself, which will be held from 10am to 4pm on Saturday, as usual.

- <u>Friday 6<sup>th</sup> October</u>, 6pm to 8pm informal gathering with a bring-and-share meal, for members of Sufferings and for any other Friends from the region
- <u>Sunday 7<sup>th</sup> October</u> representatives staying in the area will be very welcome at any of the local Meetings for Worship.

### What will be different about the agenda?

The agenda will be the same as for any other meeting. At present, we're expecting a report from Quaker Peace and Social Witness Central Committee; to reflect on Yearly Meeting 2017; and to consider BYM communications, including our Speaking Out Policy.

## How will Sufferings connect with local Quakers?

# MfS/17/04/05 Adoption of Agenda

The clerk has introduced the draft agenda, which we have agreed to.

# MfS/17/04/06 Britain Yearly Meeting Trustees' Report

Ingrid Greenhow, clerk of BYM Trustees, has spoken to the minutes of the meeting held on 17 and 18 February 2017. Her presentation has brought them to life for us today.

1. The Quaker Meeting Houses Heritage Project has come to a successful end. There are 345 meeting houses, 46% of which are listed. Friends are thanked for their engagement with this work. We currently have a property support officer who is helping support meetings with their property issues.

- 2. Trustees will be considering options for BYM's continuing commitment to support an Edinburgh-based Scottish Parliamentary Engagement Officer who will work with Friends in Scotland to advocate peace and truth and equality in the Scottish Parliament.
- 3. We have heard of the continuing strong relationship between BYM and QUNO and the legacy funding for their project on Human Impacts of Climate Change.
- 4. Friends House has received a Carbon Smart gold certificate for reducing its carbon footprint by 29% since 2009.

Peter Ullathorne, Yearly Meeting Treasurer, has told us that the 2016 accounts have been approved by the trustees and will be available for discussion at our next meeting.

We have been able to ask questions. We have heard about Quaker Life's initiatives to address the problems of ageing and declining membership. We encourage Friends to consider how they can communicate their work in a more accessible way.

We thank the Trustees for their work.

## MfS/17/04/07 Quaker Stewardship Committee

Ursula Fuller and Mary Aiston of Quaker Stewardship Committee have spoken to its report (MfS 2017 04 06). We have also received minute 2017/21 from Leeds Area Meeting.

Like Sufferings, QSC has a vision of vibrant, well-managed meetings that can develop innovative solutions to the problems facing them. Like Sufferings, QSC works primarily with area meetings. Sufferings works on our faith and action, QSC looks after the good governance that underpins it.

QSC has helped our area meetings so that in 2016, Yearly Meeting was told that every meeting that has to send their annual report and accounts to the Charity Commission or to the Office of the Scottish Charity Regulator met the deadline and the reports contained all necessary requirements.

We reaffirm that all Quakers should be good stewards of our resources: it is part of our witness in the world to do this job well and there is ongoing work needed to support meetings in their stewardship of our resources. We have considered the three questions that QSC has put before us:

1. What more can QSC and area meetings do to ensure that trustees and treasurers receive the support they need?

Initial feedback from representatives today was positive: the support QSC offers via Trustee and Treasurer News and their willingness to work with Friends in their meetings is appreciated.

News of Woodbrooke's proposed online course was welcomed. Feedback on annual reports from QSC link Friends is also helpful.

A proactive approach is needed to engage Friends in matters of governance, as there are difficulties in some areas in finding Friends to serve. Friends would welcome QSC members visiting them in their area meetings.

2. Would making wider central use of the information provided in trustees annual reports and accounts be a worthwhile expenditure of BYM's resources?

In responding to this question, we were reminded of the opportunity annual reports provide for outreach to the wider world. They are a report on the life of the whole area meeting and whilst legally their production is the responsibility of trustees, we are reminded of the guidance in Qf&p 15.03 that the ultimate authority lies with the gathered meeting.

Asking for reports to provide information about, for example, sustainability, would require clear guidelines to enable consistency.

We were urged not just to follow the letter, but to respond to the Spirit.

3. How can QSC best prompt a wider conversation to ensure that BYM's governance structures are sustainable in the long term?

We acknowledge that there is no 'one size fits all' and there are limits to Friends' ability and willingness to sustain the work of governance. This is a serious risk.

We thank Ursula Fuller and the members of QSC for their report to us today and for their work for the Yearly Meeting and we will return to these matters at a future meeting.

We look forward to hearing further comments when all representatives have reported back to their meetings.

# MfS/17/04/08 Quaker faith & practice: proposed revision to section 14.40

Last December, MfS approved some proposed changes to Quaker faith and practice section 14.40 (Quaker Stewardship Committee), and forwarded them to Yearly Meeting (minute MfS/16/12/16). Church Government Advisory Group (CGAG) had overlooked recent changes to the terms of reference to Quaker Stewardship Committee. Accordingly, it now suggests a simplification to the wording of section 14.40 as set out in paper (MfS 2017 04 07).

We agree to this proposed amendment, and forward it to Yearly Meeting.

## MfS/17/04/11 Quaker World Relations Committee

Barbara Windle, Quaker World Relations Committee representative to Meeting for Sufferings, has presented its report (paper MfS 2017 04 10).

The report details the many ways in which QWRC works to fulfil its purpose of 'enriching understanding between Friends worldwide and engaging Quakers in Britain in Quaker issues around the globe'. There are particular challenges in working globally in the context of our YM commitment to sustainability. We are glad to read that legacy funding has just been agreed for a sustainability communications officer whose key role will be to gather information about worldwide Quaker action on sustainability and to facilitate collaboration and movement building.

One of the ways in which Friends in Britain can engage with Quakers nationally and internationally is to join the Quaker World Relations Network.

We are delighted at the breadth and scope of the work done in our name.

## MfS/17/04/12 Letter of Greeting to Ireland YM

We receive from Quaker World Relations Committee a draft for our letter of greeting to Ireland Yearly Meeting to be held at Rathgar, Dublin, over the weekend of 20-23 April 2017 (paper MfS 2017 04 11).

# MfS 17/04/13 Towards a vision of a criminal justice system

Further to minute MfS/16/12/18, we receive minute 7 of Hampshire and Islands AM held on 14 January 2017, and minute 9 of Hampshire and Islands AM held on 9 July 2016. We note that the earlier minute was sent to Meeting for Sufferings last year, but due to an administrative error it was not shared with Meeting for Sufferings when we considered the matter last December.

We forward the minute to Quaker Peace & Social Witness Central Committee, for its Crime, Community and Justice sub-committee.

#### MfS 17/04/14 Vulnerable adult members

We receive minute 17/02/11 Concern: Vulnerable Adults from Brighouse West Yorkshire AM, held on 12 February 2017. The experience of supporting a vulnerable adult has led the Area Meeting to seek to ensure good Quaker collective practice in similar situations. The Area Meeting recognises this can be complex, and suggests that guidelines for good practice might be provided, to be shared nationally through Quaker Life.

We forward this minute to Quaker Life Central Committee, asking them to take this forward, and to report on progress later this year. We also forward it to Quaker Stewardship Committee, asking them to send any comments to Quaker Life Central Committee.

# MfS 17/04/15 Transgender and non-binary inclusion

We receive minute 17.21 of North East Thames AM, held on 18 February 2017, attaching a statement concerning the inclusion of transgender and non-binary people in our Quaker communities. We welcome the opportunity to increase our learning about this issue - non-binary people are those who do not identify as either male or female.

We forward this minute to Quaker Life Central Committee for their consideration.

Further to our minute 2015/03/09, the Recording Clerk has told us that the tabular statement now contains a third column for those choosing not to be listed as male or female.

## MfS 17/04/16 Quaker Recognised Bodies

Further to minutes MfS/15/12/1 and MfS 16/07/19, we receive paper MfS 2017/04/13 recommending three groups for registration as Quaker Recognised Bodies.
