MfS/18/02/04 Agenda

The clerk has introduced the draft agenda, and we have agreed to this.

MfS/18/02/05 Court and Prison Register

We note that some of the details recorded at our meeting last October were inaccurate in relation to three of the six Friends who were arrested in September 2017, during a Meeting for Worship outside the Arms Fair organised by Defence and Security Equipment International (DSEI) at the ExCeL centre in Docklands, London.

We record now that on 19 September 2017, Chris Gwyntopher (North East Thames AM) and Hank Eynattan (Kingston and Wandsworth AM) were found guilty of obstruction of the highway and were released on six months conditional discharge and fined £85 court costs plus £20 Victim Support surcharge. Paul Milling (Kingston and Wandsworth AM) pleaded not guilty to obstruction of the highway and his case was not proceeded with.

We agree to include this updated information in the Court and Prison Register.

MfS/18/02/06 Central decision-making processes in Britain Yearly Meeting

We receive minute 17.73 from Kingston & Wandsworth AM held on 19 November 2017 regarding a concern setting priorities for centrally-managed work. This minute builds on two minutes previously sent to Meeting for Sufferings (MfS) by Kingston and Wandsworth AM, titled 'Central decision-making processes in Britain Yearly Meeting: a cause for concern?', which were both received in June 2017. At the June 2017 meeting, a period of threshing did not enable MfS to reach clarity about the way forward; MfS Arrangements Group was asked to consider this further and report back. We note that the work of MfS during 2017 has been reviewed against the functions listed in Quaker Faith and Practice Chapter 7.02 and that further guidance on central decision-making will be included in the MfS Handbook. We also note that MfS Arrangements Group is planning to set aside time in October 2018 for further consideration of this matter.

MfS/18/02/07 Review of Committee on Clerks

We receive draft terms of reference for the Yearly Meeting Committee on Clerks review group (paper MfS-2018-02-07). We approve these terms of reference.

MfS/18/02/08 Date of Yearly Meeting 2020

Further to minute S/11/02/08 which agreed a three-yearly pattern for the dates of Yearly Meeting, we receive YMAC minute 2017/09/15 regarding the dates of Yearly Meeting 2020. YMAC recommends that Yearly Meeting is held 1-8 August 2020 at the University of Bath. We agree to this.

MfS/18/02/09 Yearly Meeting 2018

We welcome Deborah Rowlands, clerk of Yearly Meeting, who has shared information about the planned agenda for Yearly Meeting 2018 and has encouraged us and our meetings to begin to prepare for it.

Agenda Committee was urged to continue embracing the use of technology in sharing in the participation in Yearly Meeting.

We thank Deborah Rowlands and Yearly Meeting Agenda Committee for their work.

MfS/18/02/10 BYM Sustainability Group report

"I tell you naught for your comfort, Yea naught for your desire Save that the sky grows darker yet, And the sea rises higher."

We have welcomed Lis Burch, clerk of BYM Sustainability Group, who spoke to the report on progress made by the BYM Sustainability Group (paper MfS 2018-02-9a).

BYM Sustainability Group is a working group of Meeting for Sufferings, set up in 2014 to provide "a leadership role, similar to eldership and oversight" in relation to the Yearly Meeting's Canterbury Commitment to become a low carbon sustainable community. We recognise that we still need to see more engagement from individuals, local meetings and area meetings across the Yearly Meeting if we really want to see that Quaker values are active in the world. We have been challenged to consider "what is the meaning of a Yearly Meeting concern, if we as a Yearly Meeting don't do it?" Is this the best that we can be?

The Group has been working collaboratively with various committees and external bodies and we are glad to have sight of the schedule detailing progress in addressing the recommendations for action which were revised last year (paper MfS 2018-02-09b).

We note that the biennial national gathering will be held at Swanwick on 19-21 October 2018 and Area Meetings are encouraged to appoint Friends to attend. Area Meetings are also encouraged to consider signing the statement of intention of all faith groups (http://www.interfaithclimatestatement.org) which came from the 2017 Bonn climate conference.

We thank the Group for their report today and for their work and note that we will return to the question of how to take this concern forward at our next meeting when we receive the report of the BYMSG Review Group.

MfS/18/02/11 Transgender and non-binary inclusion

In February 2017, Meeting for Sufferings received and noted a statement made by North East Thames AM, concerning the inclusion of transgender and non-binary people in our Quaker communities. We welcomed this opportunity to learn more about the issue, and forwarded the statement to Quaker Life Central Committee for its consideration. Minute MfS/17/04/15 refers.

We now receive QLCC minute 17.89. QLCC is considering how best to help meetings explore these issues; and notes that because understanding of these issues is still evolving rapidly, the learning process may take quite some time.

MfS/18/02/12 Vulnerable adult members

In April 2017, Meeting for Sufferings sent QLCC a minute regarding Meetings' support for vulnerable adults, a matter which had been sent by Brighouse West Yorkshire AM (MfS/17/04/14). QLCC has reported that it hopes to be able to circulate good practice guidelines soon.

MfS/18/02/13 Pastoral care of unattached Friends

Yearly Meeting 2014 (minutes 10 and 40) asked Meeting for Sufferings to work with Quaker Life Central Committee (QLCC) to seek the views of Friends, particularly young adult Friends, whose life journeys may preclude them committing to a local or area meeting, and to consider how to respond to the call for a more flexible approach to membership in such cases. Our minute MfS 2014/09/07/a Membership refers.

QLCC has reported previously that it had set up a working group. QLCC has now reported that this group has been laid down and the Central Committee is continuing its consideration.

MfS/18/02/14 Quaker Life Central Committee

We have welcomed Jocelyn Bell Burnell, co-clerk of Quaker Life Central Committee (QLCC), who spoke to its 2017 report to Meeting for Sufferings (paper MfS 2018-02-10a). The terms of reference of QLCC cover faith and practice, spiritual nurture and the practical tasks required for the running of our Quaker meetings.

We receive minutes QLCC 17.84 and QLCC 17.86, Our strategy; and QLCC 17.87, Our strategic priorities, along with the Quaker Life Central Committee Strategy for Quaker Life, 2018-22 (paper MfS 2018-02-10b). The QLCC report highlights the development of strategic aims for 2018 – 22 which will shape the future work of the Committee and staff. The strategy statement is structured in six sections, matching the six sections in Our Faith in the Future. QLCC has identified three initial priority areas, and has invited Meeting for Sufferings representatives to respond.

We have spent time in home groups, geographically arranged, and have considered questions about identification of the 'big issues' in the area of Quaker Life and what should be the most important strategic aims of the Central Committee.

Reflecting together in plenary, we have heard that meeting for worship remains the bedrock of living as a Quaker but we need to prepare for it and we need to nurture our spiritual foundations. Knowing and understanding our Quaker discipline also needs to be a priority.

The heartbeat of our Quaker life is the meeting for worship and if it is not beating strongly, where will we find support as we go out in the world?

We thank Jocelyn and the members of QLCC for their work and time with us today. We note that we expect to receive reports from all Central Committees at our residential meeting at the end of 2018 where we will be able to consider further the strategic priorities within central work. We forward this minute to QLCC.
