## Clarify relationship. Not creating a relationship

Bringing into the light what relationship we already have ~ to share the understanding of what are our duties to, and expectations, of each other BYM:AM, AM:AM

MoU to clarify relationship. Have to be sure the guidance from BYM does not impinge on the independence and decision making of AMs as separate charities, but at the same time respects and reminds them of their liability for their decisions

## Clarifying the relationship between charitable bodies of the Religious Society of Friends (Quakers) in Britain

The aim of this illustration is to help articulate the relationship of the umbrella body, the Church, and the charitable bodies of the organisation.

We hope this will help strengthen the understanding of the shared mutual duty of care to uphold the purpose and reputation of the Church, and to recognise the responsibilities and accountability between the charities within the Church.

## **Church Structure**

The 496 *Local Meetings* LMs around Britain where Friends meet and form their local Quaker communities for worship and witness. They are the fabric of the Church (*the fabric of the brolly*).

The Area Meetings AMs draw together Friends from neighbouring LMs to become a wider

Quaker community for spiritual and social development, and for membership and administrative purposes (*the pattern on the brolly*).

The Church, The Religious Society of Friends (Quakers) in Britain, commonly shortened to Britain Yearly Meeting or Quakers in Britain QiB is the umbrella body giving the structure of the Church. It provides strength, purpose and identity for Friends, and support for AMs and LMs (the shape of the brolly).

The direction and vision of the Church is discerned by the members at the annual meeting, Yearly Meeting in session YM, or by Meeting for Sufferings MfS between sessions. The decisions made at YM and MfS guide the Church (*the handle of the brolity*).

Meeting for Sufferings is made up of members of the LMs appointed to serve

in a variety of roles; representatives of AMs, General Meeting for Scotland GMfS, Meeting of Friends in Wales MFW and Young Friends General Meeting YFGM, central committee members CC and Britain Yearly Meeting trustees BYMT. Meeting for Sufferings is supported by staff.

Members share in the responsibility of caring for their own LMs, doing the work at AM level and filling the roles for the deciding on the central work. Appointments are made via a nominations process and are usually for a three-year period, a triennium. Friends are sometimes appointed for a second triennium.

## Charity Structure

Underneath the umbrella of the Church are 74 charitable bodies whose charitable status is conferred by them being part of the Religious Society of Friends (Quakers) in Britain QiB.

Britain Yearly Meeting BYM, is the charity responsible for the central work and assets of the Society (*the central body*).

It provides support to all parts of the church, LMs, AMs and regional bodies. And all parts of the church support the central work (*the spokes of the brolly*)

There are 70 Area Meetings AMs and each is responsible for the work and assets of the area meeting, including those of all the local meetings within it (*the pattern on the brolly*).

General Meeting for Scotland GMfS and Meeting of Friends in Wales MFW are regional meetings providing a national body for their respective countries.



Young Friends General Meeting YFGM is the national community for young adult quakers throughout Britain.

Whilst each of these charities is a separate legal entity, they are bound together by their purpose and charitable objective to further the general and religious purposes of the Religious Society of Friends (Quakers) in Britain, as laid down in our Book of Discipline.

As such they all share the duty of care to uphold the purpose and reputation of the Church.

A failure by any one part could affect and damage the integrity, structure and reputation of the whole church

An overarching statement of principle - that the different charities which form our national church are mutually interdependent.

A document which sets out the headings of issues which are of relevance to the relationship between the various charities within the church (the trustee bodies of AMs, General Meeting for Scotland, Meeting of Friends in Wales, YFGM and BYM). This might be called an MoU. It can be developed by BYM Trustees working with AM Trustees and other Friends.

'Toolkit'-type material, with details about how to uphold these mutual responsibilities - which are developed and updated with staff.

• The church is supported by charities who hold property, and carry out the legal, health and safety, financial and employment work necessary to enable us to meet and worship and witness.

• Each of those charities is a separate legal entity, but they are bound together by their purpose and charitable objective to further the general religious and charitable purposes of the Religious Society of Friend (Quakers) in Britain and beyond, as laid down in our Book of Christian Discipline

• Our central and local charities within the church exist solely to support our worship and witness as a Quaker community. *Right ordering* requires us to work together to ensure we are best able to support worship and witness, to discern together and to follow the promptings of love and truth. Area meetings must work together with other area meetings and with BYM to uphold the integrity and reputation of the church. That places upon us mutual obligations for Area Meetings, General Meetings and BYM to work together, to ensure we live out our commitments to truth, equality, inclusion, sustainability, peace and provide a safe environment for those who come to our meetings. This includes ensuring we value the uniqueness of each quaker community, as part of the whole, that we consider the risks to others in the national church community, that we recognise our obligation to raise the funds needed to carry out the work we ask of BYM, to work positively with BYM to address shared challenges, and for BYM to respond to the needs of our diverse Quaker communities.
