Meeting for Sufferings recommends amending section 13.19 to reflect the decision of Meeting for Sufferings to adopt a new ‘Quaker recognised bodies’ system in place of the existing ‘listed informal groups’ system. Meeting for Sufferings also recommends minor consequential amendments to sections 11.05 and 11.11, replacing the phrase ‘listed informal group’ with the phrase ‘Quaker recognised body’.

**b) 8.20 and 14.40 Changes to Management Meeting**

Meeting for Sufferings recommends amending section 8.20 The Recording Clerk and section 14.40 Quaker Stewardship Committee to reflect agreed changes to management meeting and job titles.

# Proposed revisions to the terms of reference of the Yearly Meeting Nominating Group

Nominations committees are appointed in many ways. Sometimes names are suggested from the body of the meeting, on other occasions a special committee is asked to bring forward names of Friends to serve on the nominations committee.

*Quaker faith & practice* 3.24d

## 1. Summary of purpose

- 1.1 The Yearly Meeting Nominating Group acts as the nominating body for the nominations committees of Yearly Meeting i.e. the Central Nominations Committee and the Committee on Clerks. This is so that a body separate from those nominations committees considers the membership of the nominations committees.

## 2. Membership

- 2.1 The Yearly Meeting Nominating Group is nominated in two different ways:
- 2.2 Six to eight Friends are appointed by Yearly Meeting each year, to serve until the end of the following Yearly Meeting. Normally, the Friends so appointed will be present at Yearly Meeting, and generally they should be in membership of Britain Yearly Meeting and not have served on the Nominating Group in the previous year.
- 2.3 The convener is nominated by the previous year's Yearly Meeting Nominating Group generally from within its membership. A convener is not eligible for immediate reappointment.
- 2.4 The Recording Clerk, or another member of staff designated by the Recording Clerk will normally attend committee meetings to act as secretary to the committee. Meetings without the secretary should only be with that person's or the Recording Clerk's agreement.

## 3. Frequency of meetings

- 3.1 The group shall meet as required to discharge its duties. Generally it shall have a face to face meeting as soon as practical after its appointment, followed by meetings held by teleconference or other similar methods.

## 4. Duties & responsibilities

- 4.1 To respond to the request of Yearly Meeting by nominating Friends to serve as minuted by the Yearly Meeting. It should do this by bringing forward, and notifying the Recording Clerk accordingly in time for inclusion in the appropriate documentation in advance of Yearly Meeting
  - a) Friends to serve on the Committee on Clerks for a three-year period from the rise of the Yearly Meeting. (*Qf&P* 6.19)
  - b) Friends to serve on the Central Nominations Committee for a three-year period from the rise of the Yearly Meeting. (*Qf&P* 6.21)
  - c) The numbers of Friends required in a and b will be determined by the desired size of those committees, and will generally be one-third of the membership.
  - d) Friends to fill casual vacancies on these two bodies, including any vacancies caused by the nomination and expected appointment of clerks to these bodies.
  - e) one Friend to serve as convener of the next Yearly Meeting Nominating Group.
  - f) any other nominations that are included in an appropriate schedule or minute agreed by Yearly Meeting.

- 4.2 To have clear ideas of the qualities required of Friends serving in the roles they are required to nominate.
- 4.3. To ensure that Friends approached with a view to nomination shall have a full understanding of the responsibilities and commitments involved in the role for which they are being nominated.
- 4.4 To create and maintain collaborative relationships with the Central Nominations Committee and the Committee on Clerks, drawing upon their procedures and practices as appropriate and desirable.

## **5. Authority**

- 5.1 The committee shall work within these terms of reference under the authority of section 6.22 of *Quaker faith and practice*. The Yearly Meeting Nominating Group is accountable to Britain Yearly Meeting in session.
- 5.2 These terms of reference should be reviewed at least triennially and may in the interim be amended by minuted decisions of Britain Yearly Meeting in session or Meeting for Sufferings.
