### MfS/15/07/07 Yearly Meeting 2015

We note the minutes of Yearly Meeting held in London on 1-4 May 2015.

Deborah Rowlands YM clerk designate, has introduced our consideration on Yearly Meeting, in particular putting it in the context of our relationship with Yearly Meeting Agenda Committee.

## MfS/15/07/08 Proposed revision of Quaker faith & practice section 3.27

Further to our minute MfS/15/02/16, we receive minute 32 of Yearly Meeting 2015. We ask Church Government Advisory Group to review this section of Quaker faith and practice, regarding our speaking out policy, and to report back to us.

### MfS/15/07/09 Call for Equality

We receive minute 36 of Yearly Meeting 2015: Living out our faith in the world – are we ready to meet the challenge'. We also note minute 25: Responding to social inequality and injustice: housing as a tested concern.

Yearly Meeting asked Meeting for Sufferings:

"... to take the work on social and economic injustice forward, co-ordinating the work of local and area meetings who might wish to become more deeply involved, and encouraging the deep spiritual and intellectual searching that could underpin a 'true social order' for our age."

We have reflected together on these minutes and shared our deep disquiet about housing, economic inequality and climate change, recognising their inter-relatedness.

We ask our Arrangements Group to look at how we might consider these issues at future meetings.

We are encouraged to hear that further to minute YM2015/25 the Quaker Housing Trust is planning a threshing conference to explore how Friends can take forward our concern for housing.

We ask QPSWCC, when it reports to us in September, and QLCC, when it reports to us in December, to let us know how their current work and future plans relate to this call.

#### MfS15/07/10 Refugees and asylum-seekers

We receive paper MfS2015/07/07a, which contains minute QPSWCC15/12 and minute 9 of East Kent Area Meeting held on 28 March 2015, and paper MfS2015/07/07/a(i).

We have heard a short briefing from Helen Drewery, General Secretary of QPSW, which is available in writing to share with Friends.

We are glad to hear that QPSW is exploring with Quaker Asylum and Refugee Network (QARN) how they can work together more closely.

This is a European-wide issue. We welcome the papers we have received from European churches. We have heard that Quaker Council for European Affairs (QCEA) is looking at these issues and encourage them in this work.

We note that other faith groups as well as NGOs are actively campaigning on these matters, and urge Friends to work alongside and support such initiatives and to challenge the rhetoric where possible and appropriate.

### MfS/15/07/11 Sustainability & new energy technologies

We receive minute 15/20 of Wensleydale and Swaledale AM held on 8 March 2015, expressing concern that Friends need to put more emphasis on adapting to inevitable climate change. The Area Meeting also urges Friends to speak out more decisively and urgently about climate change, and particularly to ask the Government to divert funds from the manufacture of arms to investment in new forms of energy. We forward this minute to BYM Sustainability Group and ask for advice. We also send the minute for information to QPSW Central Committee.

### MfS/15/07/12 Transatlantic Trade and Investment Partnership

We receive minute PHAQM/AM/2015/9 of Pickering and Hull AM held on 8 March 2015, expressing the Area Meeting's concern regarding the Transatlantic Trade and Investment Partnership.

We have learned that Quakers in Britain are working on this issue through QPSW's Economics, Sustainability and Peace programme, nationally, and that QCEA and QUNO also have a role internationally. We support them in this work and encourage Friends locally to engage with these issues, including taking the matter to their MPs and MEPs where appropriate.

### MfS/15/07/13 WW1 Memorial Meetings for Reconciliation

We receive minute 15.05.06 of Luton and Leighton Area Meeting held on 10 May 2015, expressing the hope that meetings to commemorate World War 1 are multinational, focusing on reconciliation and committing participants to peace-building. We ask representatives to alert Friends locally to this concern, for them to explore practical possibilities.

We forward this minute to QCCIR for advice.

### MfS/15/07/14 National Memorial Arboretum – Memorial to the Innocent Victims of War

Further to minute MfS2014/04/13/04 we receive minute 15/38 of Southern Marches Area Meeting held on 9th May 2015, updating us on their progress towards the establishment of a memorial to innocent victims of war, at the National Memorial Arboretum.

We agree to return to this at a future meeting.

## MfS/15/07/15 Representatives to Friends World Committee for Consultation

We receive minute QWRC/15/06/07, regarding representation at the Friends World Committee for Consultation (FWCC) plenary in Peru in January 2016. As two of our appointed representatives are prevented, we agree that Liz Scurfield and George Thurley should represent us, for this meeting only.
