MfS/17/10/04 Agenda

The clerk has introduced the draft agenda, and we have agreed to this.

MfS/17/10/05 Court and Prison Register

Further to minute MfS/17/02/04, we have heard that Sam Walton of South London AM is due to appear in court on 24th October, charged with criminal damage, in relation to an action to disarm warplanes in February.

Sam Donaldson, an attender at Hull meeting (Pickering and Hull AM), was charged with breach of the peace at Faslane naval base on 13 July 2017. He is due to appear in court on 12 October.

We have also heard that nine Friends were arrested in September outside the Arms Fair organised by Defence and Security Equipment International (DSEI) at the ExCeL centre in Docklands, London. Six of the nine were arrested during a Meeting for Worship.

On 19 September, three Friends pleaded guilty to obstruction of the highway and were given six months conditional bail and £95 costs: Hank Eynattan, Kingston and Wandsworth AM; Paul Milling, Kingston and Wandsworth AM; and Chris Gwyntopher, North East Thames AM.

The following Friends were charged with obstruction of the highway. Some will appear in court at a later date, while others have had charges dropped following an initial court appearance: David Amos, Kingston and Wandsworth AM; Susan Clarkson, Brighouse West Yorkshire AM; Richard Levitt, of Leeds AM; Simon Watson of South East London AM (also Ohio Yearly Meeting); and Jo Frew, an attender at Tottenham meeting (North London AM).

David Henshaw of North West London Area Meeting was arrested for aggravated trespass.

We agree to add the names of all these Friends to our court and prison register, and we hold them in the Light.

MfS/17/10/06 Articulation of 'our faith' on the BYM website

We receive minute 2017/05/02 from West Kent AM expressing the view that the 'Our faith' section of the BYM website is inadequate in representing honestly the diversity of Quaker experience.

This part of the website was designed to provide a very brief introduction to people with very little knowledge of the Quaker way. A new version has been developed which includes different expressions of Quaker faith. We encourage Friends in West Kent AM in their continuing consideration of how best to communicate *Quaker faith & practice* to others.

We reaffirm that all aspects of Quaker outreach are important to us and we send this minute to Quaker Life Central Committee for their information.

MfS/17/10/07 Quaker Stewardship Committee

Further to minute MfS/17/04/07, we receive minute 2017/04/04 from Quaker Stewardship Committee (QSC) regarding two-way communication between local Meetings and QSC. As noted in April, we will return to these matters at a future meeting.

MfS/17/10/08 Quaker World Relations Committee: The Future of Europe

We receive minute 2017/05/07 of Quaker World Relations Committee (QWRC) with a copy of its response to the Conference of European Churches (CEC) draft Open Letter on the future of Europe.

We are pleased to have the opportunity to read this letter from the CEC and in particular its aim 'to foster hope and cultivate constructive solutions' and its affirmation of 'respect for human dignity, peace, justice, freedom, tolerance, participation, solidarity and sustainability'. We note the statement that 'Solidarity with refugees is a consequence of Christian faith and our commitment to working towards a just and compassionate society' and the way in which FWCC has referred to the concern that Quakers have for the plight of refugees and migrants. The FWCC response (A European Quaker contribution) is a helpful document in its own right and we commend it to wider readership and use amongst Quakers. We send this minute to QWRC for information.

MfS/17/10/09 500th Anniversary of Lutheran Reform

We receive minute 17/48 of Quaker Committee for Christian & Interfaith Relations accompanied by a paper marking the 500th Anniversary of the Lutheran Reformation.

We are pleased to have sight of this paper covering aspects of Quakerism and reformation and hope that it may be useful for Quakers in their study generally.

MfS/17/10/10 Quaker Council for European Affairs

In December 2016 we received a report from our representative to Quaker Council for European Affairs (QCEA). Our minute MfS/16/12/08 asked our representative(s) report to Meeting for Sufferings every three years, and also to report to QPSWCC, annually if possible, regarding issues of common concern. We now receive minute 17/54 of Quaker Peace & Social Witness Central Committee recording that it has received its first annual report from QCEA.

MfS/17/10/11 Ackworth School General Meeting

We receive minutes 8a and 8b of Ackworth General Meeting which record that BYM is not regarded as the direct owner of Ackworth School and that the governance of the school rests with

Ackworth General Meeting. These minutes confirm and clarify decisions taken by Meeting for Sufferings in 1998, 2001 and 2007 (minute MfS/07/03/13 refers).

This will mean that this is the last time Meeting for Sufferings is asked to note such changes.

MfS/17/10/12 Appeal Group

In October 2016 we agreed to establish a group to consider an appeal made under the guidance set out in Quaker faith and practice chapter 4 (minute MfS/16/10/16). The Appeal Group has carried out its work and reported its findings both to the appellant and the Area Meeting concerned. Accordingly, we lay down this group and thank its members for their service.

MfS/17/10/13 Meeting of Friends in Wales

We note Meeting of Friends in Wales is celebrating its 25th anniversary and we send greetings to all Friends there.

MfS/17/10/16 Quaker Peace & Social Witness Central Committee annual report

Jeff Beatty, Quaker Peace & Social Witness Central Committee (QPSWCC), has spoken to the annual report outlining the great breadth of work carried out by a paid staff of 20. This encompasses peace and conciliation work abroad, peace education at home, economic and criminal justice, and work on migration, as well as collaboration with Quaker United Nations Office, Quaker Council for European Affairs and Quaker Housing Trust. It is a truly impressive programme.

Quaker Peace and Social Witness Central Committee continues to wrestle with the challenges presented by pressure to be more active on such a wide range of issues, and with the difficulties in balancing long-term (budget) and short-term (including legacy or grant-supported) funding.

We are glad to hear of collaboration with other faith groups and the growing links with Quaker Life. We are supportive of the way the work is developing. We realise that there are challenges in balancing the demands of work at central and local level and want to liberate Friends and others to grow our work for peace and justice.

MfS/17/10/17 Sanctuary Everywhere Manifesto

Helen Drewery told us about the development of the Sanctuary project and the proposed 'Sanctuary Everywhere' Manifesto (minute QPSWCC 17/29 refers). The work grew out of the concerns of Friends and legacy funding enabled a pilot project – a listening exercise in the yearly meeting – which has been extended for a further two years. Local meetings are being supported by Quaker Peace and Social Witness to join local initiatives that create a culture of welcome, and to foster their involvement in campaigning and advocacy.

The six points of the manifesto have grown from many statements made by Britain Yearly Meeting in recent times and will allow Quaker Peace and Social Witness to work with organisations such as Amnesty and the Refugee Council.

We appreciate the work that has gone into developing the manifesto and support the principles behind it whilst recognising the difficulties that may be encountered in practice.

We feel it is important to make more explicit the Quaker basis behind the manifesto, and refer it back to Quaker Peace and Social Witness.

MfS/17/10/20 Yearly Meeting Gathering 2017

We have reflected on Yearly Meeting Gathering 2017 held at the University of Warwick from 29 July to 5 August 2017, the theme of which was Living out our faith in the world: working with others to make a difference.

Friends spoke of the impact that Yearly Meeting Gathering has had. In particular we noted that the gathering was lively, nurturing and well-organised, including a role for young adults. The wider use of technology meant that those not physically present felt included. We are thankful to all those involved in making this event a success.

We send this minute to Yearly Meeting Agenda Committee.

MfS/17/10/21 Committee on Clerks

We receive minute 23 of Yearly Meeting 2017 asking Meeting for Sufferings to undertake a review of the Committee on Clerks. We agree to establish a short-term review group. We ask the Recording Clerk to draft terms of reference and Central Nominations Committee to bring three names.

MfS/17/10/22 Diversity and inclusion

We receive minute 38 of Yearly Meeting 2017 asking Meeting for Sufferings to consider diversity in our committee and organisational structures, and particularly to look at how Quakers can remove barriers and actively seek wider participation in the full life of our meetings.

We recognise that we will not be able to increase diversity in committees and organisational structure without addressing wider issues. We want to learn from different experiences of our meetings throughout Britain, of other Yearly Meetings worldwide and of other churches and faith

groups. We need to be open to the Light to guide us. Change is managed best when done in a loving way and in an organic way.

We have been given some questions:

- 1. In what ways is your meeting (or committee or group) already diverse?
- 2. In what ways could it be more diverse?
- 3. What would help it become more diverse? What are the opportunities and barriers?

We ask representatives to consider these questions further with their Area Meetings or committees and respond to the Meeting for Sufferings Arrangements Group via the Deputy Recording Clerk.

We have heard today of the benefits of different ways of working in committees and groups, by using tele-conferencing, Skype and other tools.

We will return to this issue in 2018.

MfS/17/10/23 BYM Trustees report

Ingrid Greenhow, clerk of BYM Trustees, spoke to the minutes of Britain Yearly Meeting Trustees held in June in Liverpool.

The Trustees have been working together with others, hearing from the clerks of QLCC, QPSWCC and Friends House Hospitality Board. (Quakers work collaboratively.)

Ingrid drew particular attention to their approval of a MoU with Woodbrooke which forms a basis of their partnership working; and also the further 3-years of legacy funding to support parliamentary advocacy work in Scotland.

We note that Trustees are starting to think about the future of the FH restaurant and have also set up a group to review the legacy funded projects.

We thank the Trustees for their report.

MfS/17/10/24 Use of the phrase 'Quakers in Britain'

We receive BYM Trustees' minute 2017/06/09 along with a paper on the use of the phrase 'Quakers in Britain' which responds to a matter raised by Cambridgeshire AM (minute MfS/16/04/13 refers).

We thank Trustees and staff for this paper and confirm that it is appropriate to use the term 'Quakers in Britain' for public statements, as agreed by Meeting for Sufferings in 2014 (MfS/2014/02/05 Speaking Out). We note that in a few instances the term had been used inappropriately and we thank staff for now addressing this.

MfS/17/10/25 BYM Communications and Speaking Out

Paul Parker, Recording Clerk, has reminded us of the Speaking Out policy which was agreed by Meeting for Sufferings in 2014 (*Qf&p* 3.27 refers). He has told us of some of the challenges involved in Speaking Out on behalf of Quakers in Britain.

Jane Dawson, Head of External Communications, has spoken about Britain Yearly Meeting's communication work. We have heard how the strategic communications objectives of Britain Yearly Meeting are grounded in *Our Faith in the Future* and Jane has shared details of the

coverage of press statements, and social media posts. Over 13 million people were reached by Britain Yearly Meeting media in April-June 2017.

She has explained how local meetings may be supported in speaking out by the team. Every Quaker is a communicator. Knowing that Quakers are not currently widely understood by the general public, we have been challenged to do what we can. We should ask ourselves who is the communication aimed at and do we know whether it reaches the right people?

Finally we have been asked: How do representatives wish to hear about public statements made by the Communications department? At present, these are sent out to local Friends in a variety of different ways according to circumstances. We are invited to respond to the Advocacy and Public Relations Team.

MfS/17/10/26 Thanks

We would like to thank Friends in Manchester and Warrington Area Meeting for all they have done to make us feel welcome here this weekend. We enjoyed the shared meal here on Friday evening and have learnt a lot about the work and concerns of Quakers in the North West.
