## Meeting for Sufferings 10 July 2021

Dear Friends

With our meeting last Saturday we have reached the end of another triennium of Meeting for Sufferings. It must surely be the most unusual! In the last 18 months alone the Arrangements Group has cancelled, shortened, extended and added meetings, and also planned five additional information and threshing meetings. It is a tribute to you all as representatives or alternates that you have engaged with everything – perhaps reluctantly in the initially unfamiliar medium of Zoom – and we have learned much together. Thank you for all your contributions, whether spoken or silent, and for your consistent dedication and commitment.

We heard from Trustees about the financial position of the Yearly Meeting, and the annual report and accounts, along with the document *Our faith our work* are available online. The slides that were used in the meeting to illustrate finance trends are attached to this letter, and I hope you will share them with your AMs when you report back. The challenge of reaching a balanced budget by 2023 is great, and the Quaker work of putting Faith into Action needs our financial support more than ever.

As Caroline Nursey said in her introduction to the Trustees report “Central committees are responsible for discerning their priorities. Then it is for senior staff to determine how best to deliver them within the budget we set as trustees”. The priority-setting began with Meeting for Sufferings’ vision statement [\*Our Faith in the Future\*](#). Central committees – whose members are of course nominated by Central Nominations Committee and appointed by us – come back to us regularly to report on progress.

At this meeting we heard about both our worship and our witness. Staff in Quaker Life spoke about their developing work of supporting Quaker Communities. The clerks of QPSWCC, who have shared their new strategy at previous meetings, explored with us what this new strategy might mean. As we acknowledged in our minute, there is considerable tension between the process of planning for the future and the natural desire to already know the outcome. The complexity of our national organisational structure does not make this easy.

Sufferings’ role is of course to challenge, but also to listen, to learn, to understand and above all to trust and support those whom we have appointed to discern the way forward on our behalf.

Naomi Major spoke to us about the involvement of Young Adult Quakers at Sufferings. She has also sent the following:

*This year there will be a buddying scheme for young adults at Yearly Meeting Gathering. This has been set up to give those attending the chance to share the journey of Yearly Meeting Gathering with someone else. We hope this will deepen and enrich the connections between those involved. We also hope that some older Friends (over 35) will be interested in taking part to build inter-generational links. This year, this is a pilot scheme. It is only open to over 35s if they are being matched with young adults, and the number of places is limited. More details including the sign-up form are here: [2021 Buddying at YMG – QForms \(quaker.org.uk\)](https://www.quaker.org.uk) - but we need expressions of interest by Monday 19th July please.*

Some of you will be appointed for the next triennium, perhaps changing from alternate to representative, and I am looking forward to welcoming you and new Friends into our Sufferings community in October. Others of you will be leaving Meeting for Sufferings now, after service of up to 6 years, and I hope you have found your service to be on the whole fulfilling. The Yearly Meeting continues to be blessed by the number of Friends willing to give up their time to engage with the issues of Quakers nationally and to communicate those back to their own groups, and I thank you for this.






## BYM Finances 2020

With key points from the Yearly Meeting Treasurer




## INCOME

- Our income in 2020 was £16 million.
- £6 million of this was a single large legacy, designated as requested by the donor, so is not available for our general work.
- In 2020 the Quiet Company only had an income of £1.5m, compared to £5m the previous year.
- Contributions from Friends and Meetings were higher than previous years - £3million. We need to maintain this level to give us confidence for future spending and budgeting on the work we want to do.



## SPENDING

- Our expenditure was £12 million, which is less than our original budgeted expenditure of £14.5 million.
- Without the large legacy, our surplus of £4.1 million at the end of 2020 would have been a deficit of £1.7m.
- Our need to achieve a balanced budget by 2023 is unchanged.



- We carry forward a balance of £92 million at the year end: over half of this is tied up in our properties, and a further £13million is in endowment and restricted funds.

### **MfS/21/07/05 Prison and Court Register**

Ian Bray, a member of Brighouse West Yorkshire Area Meeting, has been acquitted in a landmark verdict at Southwark Crown Court on 23 April. Ian was on trial with others from the ‘Shell 7’ group, for criminal damage to the Shell HQ building in London’s Waterloo in April 2019. This was an Extinction Rebellion (XR) action which could have led to a maximum five-year prison sentence and/or a £10k fine. The jury delivered its not guilty verdict for each defendant, despite the Judge ruling that five of them had no defence under the law.

Sue Hampton, a member of Luton & Leighton Area Meeting, was arrested and charged in relation to a Climate Emergency protest in Harpenden, and appeared in court on 28 May.

Further to minute MfS/2021/04/04, John Lynes, a member of Sussex East Area Meeting, was found guilty of breaching Section 14 of the Public Order Act 1986 in the course of an Extinction Rebellion event in Parliament Square in September 2020 and ordered to pay £180 fine (for breaking the terms of a previous conditional discharge), £500 costs, and £34 victim surcharge.

We agree to include this information in the Prison and Court Register. We hold Ian Bray, Sue Hampton and John Lynes in the Light.

## **MfS/21/07/06 Quaker Recognised Bodies**

We receive paper MfS 2021 07 07. Registration of Quaker Recognised Bodies is periodically reviewed – normally five years after initial registration although emergent groups are listed for up to two years before review.

We agree to renew registration of the following five organisations as Quaker Recognised Bodies:

- Quaker Disability Equality Group (Freestanding Group for a further five years)
- Quaker Values in Education (Freestanding Group for a further five years)
- Quaker Action on Alcohol and Drugs (Externally Regulated Group for a further five years)
- Quaker Decriminalisation Network (Emergent Group – renew as Emergent Group for a further two years)
- Quaker Roots (formerly Roots of Resistance) (Emergent Group – renew as Freestanding Group for five years)

## **MfS/21/07/07 Leigh-on-Sea Local Meeting**

We endorse the transfer of Leigh-on-Sea Local Meeting from North East Thames Area Meeting to Mid-Essex Area Meeting noting this is at the request of the local meeting and has the agreement of both area meetings.

## **MfS/21/07/08 Young adult involvement in Meeting for Sufferings**

During this triennium we reserved four places on Meeting for Sufferings for adult Friends under the age of 35. Naomi Major, the Engaging Young Adult Quakers project manager, introduced her report on this experiment.

We are pleased to hear about the positive experiences of the young representatives. In considering the recommendations made in the paper Friends acknowledged the anomaly of being a representative without a constituency; however, finding a way to strengthen links to Area Meetings may be a challenge.

We are keen for the appointment of young adult Quakers to continue and we need to ensure that MfS is a welcoming space for everyone, which does not replicate a structure that works only for the already privileged.

We commit ourselves to the following actions;

1. To make clear that the call for nominations to MfS should encourage Area Meetings to appoint younger Friends and to remind them that they can send a younger Friend in place of the existing representative at any time
2. To ask the MfS Support Group to give consideration to a buddying system for new reps of any age or experience

We ask staff to continue exploring ways of taking this matter forward.

## **MfS/21/07/09 BYM Trustees and annual accounts**

We receive the minutes of the June meeting of Trustees (paper MfS 2021/07/100). Caroline Nursey, Clerk of BYM Trustees, and Linda Batten, Yearly Meeting Treasurer, introduced their report.

We have heard much about the essential nature of communication between MfS and Trustees and the need for ways to improve our mutual understanding.

The June meeting's full agenda included the first in a series of sessions of anti-racism training for Trustees, and they reached agreement on a statement for internal use, which has been published on the BYM website. We welcome this.

The Trustees' Annual Report and Accounts for 2020, and 'Our Faith, Our Work' will shortly be available on the Yearly Meeting website. Both income and expenditure have reduced as a result of the pandemic, and without the large legacy received during the year (the majority of which is designated) we would have had a deficit of £1.7m.

Finances in 2021 have been stretched and income at end-May is already 25% below that which was budgeted for the year. The Quiet Company, which usually produces a significant part of this income, is still not able to operate at pre-pandemic levels.

Expenditure was exceeding income before the pandemic and Trustees' original intention was to correct this by the end of 2024. However, with a forecast deficit of £2m, action needs to be taken sooner so that our work in the world has the income to support it.

These are challenging times, and change is inevitable. However clear the need, that change may also be painful. We know that Central Committees and staff are working together to discern priorities and determine how best to deliver them within the budget set by Trustees, and we offer them our prayerful support.

## **MfS/21/07/10 Simplification of Central Governance Structures**

Trustees Carolyn Hayman and Ellie Harding gave us a brief interim report on the five workshops with Meeting for Sufferings representatives held during April and May. There are plans for further workshops at Yearly Meeting Gathering and roadshows across Britain in the autumn with the intention of involving more Friends in this exploration.

## **MfS/21/07/11 Meeting dates in 2021–22**

In the light of consideration at MfS in June 2020, Arrangements Group has reviewed the pattern of our meetings agreed for the next triennium. Friends are concerned that there may not be enough time in this schedule for proper attention to be given to the matters before us.

After further consideration today we agree to the proposal for meetings in 2021 and 2022 in paper MfS 2021 07 12, as follows:

## 2021

- 2 October – meeting in-person, Friends House (with facilities for Friends to join online) preceded by online induction to the new triennium
- 4 December – online, with a preparation session in advance

## 2022

- 4–6 March – residential meeting (venue to be confirmed)
- 2 July – online, with a preparation session in advance
- 1 October – online or in-person (London) with a preparation session in advance
- 3 December – online, with a preparation session in advance

We ask MfSAG to keep the frequency of meetings under review, and we note additional online meetings can be arranged if needed.

### **MfS/21/07/12 Naming of William Penn Room**

We receive minutes from Northamptonshire and North Somerset Area Meetings on the decision to remove William Penn's name from a meeting room at Friends House.

We have been reminded that the decision to name rooms after Friends is part of the Quiet Company's commitment to using our buildings in ways that tell the Quaker story.

For practical reasons, the room name is unlikely to be changed until early 2022 but there is no intention to write William Penn out of the Quaker story. Trustees have asked staff to bring proposals for ways in which a full account of Quakers and slavery can be told. It will be helpful to listen to the views of a newly-emerging 'Black, Brown and People of Colour' Quaker group.

### **MfS/21/07/13 Covid security in prisons**

North Wales Area Meeting has shared its minute 21/58 (paper MfS 2021 07 13) for information. It urges all meetings to contact national government representatives asking them to address Covid security in prisons.

### **MfS/21/07/14 Quaker Peace and Social Witness Central Committee (QPSWCC) Strategy**

Following the development in 2015 of our vision statement *Our Faith in the Future* Trustees, along with Central Committees and MfS, began a process of discerning what this vision would mean for the work of BYM the charity. Priorities for the work were defined as: thriving Quaker communities, a sustainable and peaceful world, and simple structures and practices were adopted by the Yearly Meeting in 2019.

Both Quaker Peace & Social Witness (QPSW) and Quaker Life (QL) began reviews of their strategy in the light of these priorities, and QL's new strategy is already in place. QPSWCC brought us news of their progress during 2020-21 (minutes MfS 20/10/09 and 21/02/13 refer) and we expressed ourselves content with the top-level

direction of travel. The detail of the Central Committee's discernment over many months is in paper MfS 2021/07/14 along with minutes received from Central Yorkshire, Cornwall, East Cheshire, Gloucestershire, Hertford and Hitchin, Leicester, Mid-Somerset, Staffordshire, and Worcestershire and Shropshire Area Meetings.

Today's meeting provided an opportunity to hear more about the ways in which the word of the strategy might become flesh.

Robert Almond and Jeff Beatty (QPSWCC co-clerks) have spoken of the Central Committee's work so far and the challenges that still lie ahead, welcoming the comments and suggestions of Friends as they look to realise the aim that the work should be distinctively Quaker; integrated locally, nationally and internationally; and well-governed.

We have heard a call for better communication, and more participation in discussions and workshops, as well as a need to build on the good work of the past. We acknowledge the tension between planning for the future at the same time as already wanting to know the outcome.

World events over the last 18 months have had a huge impact on us all, with restrictions on our patterns of work and way of worship, loss of personal interaction and a dramatic change in our finances. Uncertainty adds pressure to a review such as this, but the Central Committee has been working hard to discern the ways in which established programmes and the work that demonstrates Friends' Faith in Action can be sustained into the future. We know that QPSW holds together a complex web of activity and recognise that the Central Committee has a vision of a more agile organisation, engaging with Quaker Recognised Bodies, Friends in the regions and Local Development Workers, and collaborating with non-Quaker partners.

We thank the Central Committee for their report and uphold them as they continue discerning the detailed shape of their work.

### **MfS/21/07/15 Support for Quaker Communities**

In April last year we received the Integrated Strategy for Supporting Quaker Communities and Quaker Life staff members Rachel Matthews, Wendy Hampton and Bridget Holtom joined us today to explain how new arrangements in Quaker Life are helping to put the strategy into practice.

We have had the opportunity to gain clarity on some of the changes.

We welcome the paper MfS 2021 07 15 which gives information in graphic form on what is being done, how, where and who is doing the work. We hope this will be shared widely with Friends.

## **MfS/21/07/16 Closing worship**

In this, the final meeting of the triennium, we have reflected on our time together with thankfulness. It has been a time of joy and frustration, of learning and seeking guidance.

In the paraphrased words of Waldo Williams:

*We have felt the support of his hand ....within a mystery that we do not always understand.*
