Meeting for Sufferings 2 October 2021

Dear Friends

Our meeting last Saturday, the first of our new triennium, was yet another in a succession of experiments. On a personal level I was delighted to be back at Friends House, but my concern was for the meeting as a whole – how would blending up to 70 online with 30-40 in person feel for all of us worshipping together? Arrangements Group meets on Tuesday next week to review the meeting and if you have any comments or suggestions to make we need to hear them. Please contact sufferings@quaker.org.uk

Communication was an underlying theme in much of the business of the meeting:

- **Trustees** reflected on the value of their pre-MfS session with us and reaffirmed their wish to have our feedback (please send via <u>neilj@quaker.org.uk</u>). Further sessions with trustees are being planned.
- The BYM weekly online publication Quake! is a valuable channel of communication reaching all Friends – not just those who attend area meetings. Information about the Autumn series of Simplification workshops being organised by Trustees is found in the edition of 30 September. The workshops run from 15 October to 15 December – please sign up <u>here</u>.
- The role of reps and alternates in **reporting back** to their area meetings is set out in *Quaker faith & practice* <u>4.17</u> and part of <u>7.02</u>

Our **business** was a mixture of the straightforward – membership, nominations, Quaker Recognised Bodies, amendments to *Quaker faith & practice* – and the more complex:

Information about action being taken to improve our safeguarding practice following the <u>IICSA report</u> on policies and practice in faith organisations.
Safeguarding is everyone's business, and we should not only be concerned for children and young people. BYM's Safeguarding Officer Mark Mitchell is available to respond to any of your concerns or queries <u>safe@quaker.org.uk</u>

- Surrey and Hampshire Border AM's minute concerning the Police, Crime, Sentencing and Courts Bill led to an important consideration of the issues, and a greater understanding of the work BYM staff are doing in the coalition of campaigners opposing the Bill. There is a <u>briefing for Quakers</u> and we are encouraged to take part in Amnesty UK's <u>'Stop the rights raid' week of action</u>
- **COP26.** The Meeting for Sufferings papers gave a wonderful overview of all the witness being undertaken. The papers are in the <u>public domain</u> so all Friends and attenders can read about this. We considered the issuing of a public statement on the Climate Emergency, and it was good to be reminded of the guidance in *Quaker faith & practice* <u>3.27</u> and our <u>'Speaking Out' policy</u> about the issuing of such statements.
- Quaker Concern for the Abolition of Torture (<u>Q-CAT</u>) reported to us, and gave a heartfelt plea for support. Please share this widely in your meetings.

Finally we received minutes from **Yearly Meeting** 2021, and MfS Arrangements Group will be looking at the ways in which we will continue the Yearly Meeting's consideration of the themes of climate justice, gender diversity and anti-racism. They will also work with the Recording Clerk on how a potential review of the role of Meeting for Sufferings might be done and bring suggestions back to us at a future meeting for further consideration.

I hope you found the meeting as I did – interesting, challenging, uplifting – and I look forward to the next opportunity in December to 'see one another's faces and open our hearts to one another'

MfS/21/10/04 Quaker Recognised Bodies

We receive paper MfS 2021 10 05. We approve the registration of:

- Bamford Quaker Community
- Quakers in the World

as Quaker Recognised Bodies under the terms outlined in the paper.

Registration of Quaker Recognised Bodies is periodically reviewed. Accordingly we agree to renew registration of Friends with Jewish Connections as an Emergent Group for a further two years, to 2023.

MfS/21/10/05 Report from BYM Trustees

Caroline Nursey, Clerk of BYM Trustees, and Linda Batten, Yearly Meeting Treasurer, have provided us with a report on the work of Trustees and we receive minutes from their meeting in September.

MfS/21/10/06 Independent Inquiry into Child Sexual Abuse (IICSA)

In 2019 Meeting for Sufferings heard from the Recording Clerk about an investigation, by the Independent Inquiry into Child Sexual Abuse (IICSA), into policies and practices in faith organisations. This did not concern individual cases.

IICSA has been set up to learn from the past, and particularly from the experience of survivors, in order to make sure children are safer in future. At the time Meeting for Sufferings minuted: "we see this as important work and we uphold everyone involved".

The Recording Clerk provided a written witness statement to IICSA on behalf of Quakers in Britain in 2019.

The IICSA report was published on 2 September. Today we receive background paper MfS 2021 10 07, introduced to us by the Deputy Recording Clerk, and she has answered our questions.

The final report from the Inquiry, and its recommendations, are expected in 2022, but we note there are matters we can act on now to make sure our communities are welcoming, inclusive and safe for everyone. Our new model safeguarding policy and its requirements on area meetings is a helpful step. We welcome the work underway in several areas outlined in the report – for example improvements in record keeping – and recognise the importance of communication between area meetings and with BYM to ensure national records are maintained.

We have been reminded that safeguarding is not just about children and young people.

Friends were glad to hear that Quaker Life has taken on responsibility for asking area meetings to report annually on their safeguarding policies and practice. It is

unfortunate that only 44 out of 70 area meetings have responded to Quaker Life with information, despite reminders.

MfS/21/10/07 Changes to Quaker faith & practice

While a new Book of Discipline is being prepared, Yearly Meeting delegated responsibility for factual amendments to *Quaker faith & practice* to Meeting for Sufferings (minutes YM 2019/21 and MfS/2019/07/05 refer).

We receive a paper from Church Government Advisory Group (MfS 2021 10 08). Church Government Advisory Group was asked to provide draft changes to *Quaker faith & practice* following Yearly Meeting's decision in 2020 to lay down Committee on Clerks and accept new terms of reference for Central Nominations Committee.

We accept the changes outlined in the paper and ask that the online version of *Quaker faith & practice* is updated accordingly. Meeting for Sufferings will report these changes to Yearly Meeting in 2022.

MfS/21/10/08 Police, Crime, Sentencing and Courts Bill (PCSCB)

We receive a minute from Surrey and Hampshire Border Area Meeting and a paper from BYM's Public Affairs and Advocacy Manager on the Police, Crime, Sentencing and Courts Bill (paper MfS 2021 10 09).

The PCSCB is very wide ranging in its scope, threatening the right to protest, imposing stringent conditions on assemblies and processions, increasing fines and the length of prison sentences, and extending the criminalising of trespass. It will have a disproportionate negative effect on groups who are already marginalised, such as Gipsy, Roma and Traveller communities and people of colour.

The Area Meeting minute acknowledges that Quakers across the Yearly Meeting are already active in opposing the PCSCB, which strikes at the heart of the rights we hold under common law and the European Convention on Human Rights.

One concern is about Part 2 of the bill, with its proposal to change how life sentences and whole life orders are managed, changes to automatic release procedures, and the introduction of what Friends consider to be disproportionate sentences for damage to memorials or creating a public nuisance. We have heard from the Recording Clerk that BYM is in touch with a group of criminal justice organisations which are challenging this part of the bill.

The report from BYM's Public Affairs and Advocacy Manager outlines what is already being done on the right to protest and freedom of assembly. Quakers are coconveners of the Civil Society Voice network and thus at the heart of work on the PCSCB. BYM staff are on the steering group of this alliance of organisations campaigning on Part 3 (protest) and Part 4 (trespass) of the bill.

As Quakers we have a long history of speaking truth to power. For us this is a matter of faith. We resist the corrosive politics of division and are reminded to love our

neighbours as ourselves, to meet one another on kinder ground and to recognise and acknowledge that of God in each other.

Our *Advices and Queries* urge us to 'respect the laws of the state but let your first loyalty be to God's purposes'.

During our consideration today Friends have expressed their deep unease about the threats to our democracy and civil liberties. To some it is a clear abuse of political power.

We are united in supporting BYM's work on the PCSCB and affirm our church's commitment to upholding democracy, defending civil liberties and human rights, including the right to freedom of assembly. We stand alongside groups whose portrayal in the media and public discourse serves to marginalise them, and recognise that it is incumbent upon us to use our privilege to empower and support those who lack such privilege.

Faith groups, charities, civil society organisations and community groups have a right and a duty to speak out on matters about which they have expertise, and where they are impelled by conscience to campaign for change.

MfS/21/10/10 United Nations Climate Change Conference in Glasgow (COP26)

The Epistle from Yearly Meeting this year reminded us:

Friends across the world have long held a concern for us to live in right relationship with creation. We grieve for the planet we love – our home – but we have no time to despair. We must act with urgency and imagination – the consequences of inaction are upon us.

The Climate Change Conference in Glasgow in November is a crucial opportunity for progress. We receive a report on involvement across our yearly meeting in the conference.

Recognising the urgency of these issues, we ask staff to prepare a statement based on our past discernment and from our further consideration here today as a focussed summary of our position for Friends and others. We expect such a statement to cover the themes of the interconnectedness of the crises we are facing and the links between climate, inequality and violent conflict; criticism of the failure of our Government to match its actions to its policies and a recognition that rich countries, through their history of colonialism, have precipitated this crisis and the need to recompense those people that have already been affected by loss and damage. We support our staff in preparing this statement and are grateful for their work on our behalf.

MfS/21/10/11 The work of Quaker Peace & Social Witness

In July we considered minutes from Quaker Peace and Social Witness Central Committee (QPSWCC) about its strategy. We also received minutes from 10 area meetings. QPSWCC expects to report later this year or early next on how its work is developing to deliver its strategy. Chilterns AM has now sent a minute and we agree to forward this to QPSWCC to include with the others for their consideration.

MfS/21/10/12 Abolition of torture

Quaker Concern for the Abolition of Torture (Q-CAT), a Quaker Recognised Body, has provided Meeting for Sufferings with a report on its work.

On previous occasions Meeting for Sufferings minuted its support, and encouraged area meetings to appoint Q-CAT correspondents, suggesting that Friends take up the concern. However, few area meetings have felt able to join Q-CAT in addressing this issue.

The experience of their recent work with staff at BYM has convinced Q-CAT of the value of this mode of collaborative working – enthusiastic local Friends supported by the expertise of specialist staff – and they recommend it to others.

We recognise the personal cost borne by Q-CAT members in taking forward their concern. Their current need is for people who can help, who would be willing to work with them – in their own words – 'to address this obscene use of power, to stem this corrosion of our human spirit. This is undiluted evil in action.'

We encourage Friends to consider whether they are able to uphold and actively support Q-CAT in its important work to address this concern.

MfS/21/10/13 Yearly Meeting 2021

We receive minutes 14, 27, 28 and 37 of Yearly Meeting 2021 which lay several tasks upon Meeting for Sufferings.

1. We ask Church Government Advisory Group to bring for our approval draft factual alterations to *Quaker faith & practice* to reflect the decision to lay down Quaker Stewardship Committee from Yearly Meeting 2022.

- 2. We lay down the group appointed to review Quaker Stewardship Committee (appointed by minutes MfS/19/02/11 and MfS/19/04/10) and thank Friends for their service with this work.
- 3. Meeting for Sufferings will take responsibility for oversight of area meeting compliance; we ask staff to bring an annual report to Meeting for Sufferings with necessary recommendations to enable us to do fulfil this duty.
- 4. Yearly Meeting asked four central committees to continue consideration of the three themes from Yearly Meeting, climate justice, gender diversity and antiracism. We ask Meeting for Sufferings Arrangements Group to encourage Quaker Life and Quaker Peace & Social Witness Central Committees to share with us examples of successful practice and look forward to hearing interim reports when appropriate
- 5. The role of Meeting for Sufferings

We receive and note Yearly Meeting minute 28 which asks us to consider the role of Meeting for Sufferings and whether this needs to be reviewed. Meeting for Sufferings Arrangements Group invited the Recording Clerk to set out for us how this might be achieved (paper MfS 2021 10 15b).

Meeting for Sufferings is already reviewing Yearly Meeting and Yearly Meeting Gathering and an interim report is due next year. Our minute of December 2020 said:

We have heard a call to take a more co-ordinated approach to our review process, considering the interrelationships between bodies and to take a radical approach to our structures not being constrained by the historical development of different bodies. We look forward to playing our part in achieving this change.

We wish to make time at a future meeting, possibly December 2021, for further discussion and ask Meeting for Sufferings Arrangements Group, working with the Recording Clerk, to plan for this.

MfS/2021/10/14 Closing worship

We have closed our meeting in worship, reflecting on our experiences of this year's Yearly Meeting Gathering.
