## Charity Commission Annual Returns Regulations 2024 (Eng & Wales, source CLAS / CC)

The Charity Commission has published guidance on Annual Returns Regulations 2024, which prescribe the information to be included in charities' annual returns from 1 January 2025 onwards.

## 2.2 Changes to Scottish charity regulations in 2025 (Scot, OSCR)

From summer 2025, charities will need to provide OSCR with details about its trustees. Then, starting at the end of 2025, full charity accounts will begin to be publicly available on the Scottish Charity Register. This is a change from charities hosting their report and accounts on their own website. When uploading documents to OSCR you may want to ensure that signatures or other sensitive information is redacted to avoid fraud. The details that charity trustees submit to OSCR will not be publicly available.

## 2.3 Block membership of the Association of Church Accountants and Treasurers (ACAT)

ACAT has been providing training and support to church treasurers since 1995 Association of Church Accountents & Treasurers when a change in the law required accounts to be prepared to a much higher standard. ACAT provides training and support in the form of training courses which take place online and at various locations around the country, a regularly updated handbook, regular e-newsletters and an advice line, www.acat.uk.com.

## 2.4 Friends Trusts Limited

Friends Trusts Limited (FTL) is the national Quaker organisation that holds ownership of Quaker property as **custodian trustee**.

Many Quaker Area Meetings and other organisations are unincorporated charities meaning the organisation isn't an entity legally. Trustees of these organisations become the **beneficial owners** of the property. FTL's role is to be the 'legal owner' of Quaker property. This means that trustees don't have to change the names on their property deeds every time the trustee body changes. It is also really helpful to have a central address for all Quaker property avoiding property getting 'lost' or possibly even stolen.

Friends Trusts does not make decisions about property but it needs to be included and instructed in any property transactions.

#### 2.6 Tabular Statement and Marriage Extracts

Each year area meetings are asked to provide information about the numbers of local meetings, members, attenders and marriages. Quakers are known for our meticulous recording keeping, so we appreciate the way that many area meetings respond swiftly to these requests.

It saves us significant staff time when we don't have to send reminders.

We would like to take this opportunity to encourage Friends to be ready at the end of the year to respond to our requests.

#### 2.7 Advice to Quaker meetings on hiring rooms

Following the **police raid at Westminster Quaker Meeting House on 27 March** we are reminding Friends that Quakers in Britain asked for advice in 2020 on hiring rooms to XR. This advice was based on the legal framework at the time, and it is necessary to remind you that the law has changed since then. New advice based on the current legal position has been requested from Bates-Wells solicitors who previously provided the advice.

When the new advice is received, it will be shared with trustees, Friends and workers who are involved in making decisions about hiring meeting houses.

A key message to anyone involved in hiring premises is to be aware of new and existing hirers, to carry out due diligence and discern if it feels safe to offer them room hire. Many Quaker meetings may well have hired a room to Youth Demand as the values of their organisation may not be seen as conflicting with Quaker values. However, keeping others users safe bearing in mind the ability of the police to forcefully enter a place of worship, may need to be part of the consideration for trustees now.

#### Employers resource update and a summary of changes in 2025

The Quaker employers' resources will very soon be updated. They resource and template documents on the website, www.quaker.org.uk/employers. All local employees are ultimately employees of a Quaker charity, usually an area meeting, that the local meeting is within.

Here is a list of the changes in 2025 which you will need to be aware of. The details of each can be found within the resource.

#### 3.4 Taking care online and being cyber-aware

Being safe online can be a challenge, especially for small charities and organisations which may include Quaker area meetings and other Quaker charities. We have a shared responsibility to look after individuals' data and do our best to take care of Quaker resources and be aware of scams and fraud.

Preventing Charity Fraud is an organisation that supports small charities and other organisations to protect their assets and raises awareness of threats they may encounter. Charity Fraud Awareness Week is one of the campaigns they offer to help support small organisations.

There is training available free online provided by the National Cyber Security Centre and is aimed at trustees and those with responsibility for charities and small organisations. The online training covers the following topics:

- Backing up your organisation's data
- Protecting against malware
- Creating strong passwords
- Keeping your devices secure
- Defending against phishing

#### Allowances, expenses and reliefs for charities (Eng & Wales, source CLAS / HMRC) 4.1

#### 4.3 Listed Places of Worship Scheme (source CLAS / UK Gov)

The Listed Places of Worship Grant Scheme will be extended until 31 March 2026. The terms of the Scheme have been modified, however; a listed place of worship will not be able to claim more than £25,000 during the financial year, though that can still be spread across multiple claims.
